

Minutes of the Fox Township Rec Board meeting August 2,2016 7:00PM

Jacob Mosier was present for an eagle scout project he wanted to do. Proposal was for work around the stage area including a retaining wall. Robin asked about cost which Jacob stated would be about 1500-2000 dollars. Don and fellow board members liked the project but felt the retaining wall would be too much for him to do and would add considerable to the cost of the project. Time frame for starting would be next summer. As the board was in favor it was mentioned to Jacob to present his proposal to the board of supervisors at their next meeting.

Tony Breindel presented the park rental requests to the rec board for their review all were approved.

Tony mentioned the last day for the summer workers was Friday august 12th. The last scheduled event for the summer would be the Elk County got talent scheduled for Sunday August 7th. As of now 12 acts are signed up and there has been a lot of interest and support for the event with a good amount of donations for it.

More discussion was held on the rubber repair or replacement for the play land at the park. Several quotes have come in and as this is a major project more products will be researched with a spring timeline for moving forward.

Grading of the area between the township building and the park for the new multipurpose field is scheduled for early September. With the time of the year seeding will be done in the spring.

Don brought to the boards attention about a band showing up to play. Evidently it was scheduled back in the spring by a former director and not cancelled after that. This was for the 80,s night event that must have been discussed back then. Kathy Dowie meet with the band and resolved the issue with the band agreeing to payment of half the original fee.

Ken mentioned everything went well with the Angela Huey run/walk.

Don filled the board in on the cruise in which was well attended and is scheduled for July 22nd next year.

Don also mentioned the fire police would like copied with a schedule of events for next year. All agreed

Tony stated the park has purchased their new leaf blower.

Don asked about the trap club and tony stated it was done. Discussion was held on how to proceed in the future with this event with maybe the Sportsman club taking it over as the best option. Further discussion to follow.

The far property line at the park is being surveyed to allow for the proper location of the new walking path on the side of the property. This also will allow for knowing where to finish with repairs to the 4 wheeler path along the far side also.

Don mentioned about copier not working, then starting to work again. Soccer appeared to be the last ones to use it.

Rob asked about the lock being pried of the door at the building at the little league fields in Toby. Tony stated someone had broken in nothing appeared to be missing.
